WEEKLY FIRE REPORT

Total Calls for Service year to date: 41

On January 6th, 2011, at approximately 11:15pm, the Pittsfield Township Fire Department was called to a reported structure fire in a commercial building in the 4000 block of Carpenter Road. Fire fighters arrived to find flames coming from several windows of the building. Fire crews initiated an interior fire attack and brought the fire under control in less than an hour. The Ann Arbor, Ypsilanti, and Ypsilanti Township Fire Departments assisted on the scene. No injuries were reported and a damage estimate was not available.

Significant Criminal Events:

Assault with Intent to Murder: 2011-121

On January 4, 2011 at approximately 8:47 pm officers were dispatched to the area of 2128 Glencoe Hills Drive for a report of a subject who had been shot. Upon the officers' arrival they located one victim who had been shot in the leg. The victim was transported to St. Joseph Hospital where he was treated and released for the injury.

The victim, along with a friend were walking through the parking lot of the apartment complex when they were approached by the suspect. An argument occurred and as the victim was walking away from the suspect the suspect fired three times striking the victim once in the leg. The victim's friend carried him to his apartment building where the police located him. The suspect fled the scene. A K-9 track was attempted but the suspect was not located. The suspect is described as a black male, 25-30 yrs. Old, 5'-10" / 180 lbs, goatee and mustache. Last seen wearing a black sweatshirt, blue or black coat.

Armed Robbery: 2011-229

On January 8, 2011 at approximately 1:23 am officers were dispatched to the 2300 block of Carpenter Rd. for a report of an armed robbery that had just occurred. Upon the officers arrival the victim stated that a black male wearing a ski mask walked up to the counter and produced a handgun. The victim stated that the suspect demanded the money from the register along with the clerk's wallets and cell phones. The suspect then ran from the front desk into the building and fled out a rear door. The victim's cell phones were found by a witness in the building as police were arriving.

Officers set up a perimeter and a K-9 from the City of Ann Arbor responded for a track. The track led to a nearby parking lot where the suspect's footprints were observed next to fresh tire tracks in the snow. The suspect is described as a black male, 5'-9" / 5'-11", heavy build, last seen wearing a black ski mask, gloves, a black vest, and tan pants.
