On March 8, 2011 at approximately 7:38 am, an officer was dispatched to the 4800 block of Clark Road for a report of a breaking and entering of a business. Upon the officers arrival it was determined that the cleaning crew discovered the damage when they arrived. Sometime between 6:30 pm on March 7, 2011 and 7:00 am on March 8, 2011 an unknown person broke out the glass door to the business to gain access. Once inside the business the suspect disabled the alarm and emptied the cash register. At the time of the report it did not appear anything else had been stolen.
