WEEKLY FIRE REPORT

Total Calls for Service year to date: 577

On March 20th 2011, Pittsfield Township Fire Fighters were called to three separate fires in the area of Washtenaw and Hogback. The first fire was a brush/grass fire, the second fire was in a dumpster and the third was in a two-story structure that caused approximately \$35,000.00 in damage. All three fires were suspicious in nature and are being investigated.

On March 20, 2011 between 2:00 and 3:00 am, a person lit three separate fires in the Carpenter Road and Washtenaw Avenue area. The fires were located in the grass behind the Ann Arbor Regent, a dumpster behind the Days Inn and the third was a structure fire at the Yotsuba Restaurant. The Pittsfield Township Fire Department was dispatched to the brush fire first and after extinguishing it they observed smoke rising from behind the Days Inn.

The source of the smoke was a fire in the dumpster which was also extinguished. Fire fighters then observed the third fire which was also extinguished but caused approximately \$35,000 in damage.

Pittsfield Township Police were dispatched to the area to assist with traffic due to the structure fire and while setting up cones in the road, Officer Beard observed a white male standing in the area watching the fire department. The subject then noticed Officer Beard and attempted to hide. The subject was detained and later interviewed. The investigation is continuing and the person that was detained by Officer Beard has been identified as the suspect. The suspect is a 26 year old Milan resident. Evidence collected at the scenes has been delivered to the Michigan State Police Crime Laboratory for examination. The investigation will be submitted to the Washtenaw County Prosecutor for review upon completion.
