**Information:** The Pittsfield Township Police Department is investigating a single car injury traffic crash that occurred on April 26, 2012 at 8:52 pm. The driver, a 19 year old Saline resident was driving a 2002 Oldsmobile Aurora on Washtenaw Ave, westbound. The vehicle left the roadway on the north side of the road, proceeded across the lawn and came to a stop after striking the side of the Ypbor Yan Chinese Restaurant, located at 4905 Washtenaw Ave. The cause of the crash may be a result of the driver losing consciousness. Further investigation is being completed to determine whether the use of alcohol and or drugs contributed to the crash. The driver was transported to St. Joseph Hospital with minor non-life threatening injuries.
