WEEKLY FIRE REPORT

Attempted Armed Robbery: # 2011-4655

On May 12, 2011 the Pittsfield Township Police Department was made aware of an attempted armed robbery that occurred on May 6, 2011 in the 7000 block of W. Michigan Ave. On that date at approximately 10:50 pm, an employee walked out to his vehicle when he was approached by an unknown male suspect. The suspect produced a knife and ordered the employee to turn over money. The employee told the suspect that he did not have any and that an alarm would go off in the business if he went back inside. The suspect then fled the area in a black colored sports car.

The suspect was described as a male, unknown race, approximately 5'-10", thin build wearing baggy pants. Anyone having witnessed the incident is asked to contact the Pittsfield Township Police Department at 734-822-4911.
