WEEKLY FIRE REPORT

Total Calls for Service year to date: **1036**

Haz-Mat Incident-Mutual Aid:

On June 4th, our members of the Washtenaw County Hazardous Materials Response Team (WCHMRT) responded to assist Augusta Township Fire Dept. with a Haz Mat incident. Fire fighters were able to contain a leak in a 1000 gallon anhydrous ammonia tank that had rolled into a ditch.

Mutual aid/Tornado/Structural collapse:

On June 6th, 2010, Pittsfield Twp. Fire Dept. was requested to assist Dundee Fire Dept. at the scene of a tornado touchdown. Fire crews assisted at the Splash Universe Hotel where there was major structural damage, but no injuries. Fire crews then assisted on M-50 near Wilcox Road on a structural collapse with a person trapped beneath the rubble. Pittsfield fire fighters along with the Washtenaw County Technical Rescue Team and other departments worked for almost four hours to stabilize and successfully extricate the victim from the collapsed structure. Pittsfield fire fighters also checked multiple other structures with major damage to insure that there were no other victims.
