Home Invasion: #2010-5680

Officers were dispatched to the 3200 block of Hillside Drive for a reported home invasion that occurred on June 8, 2010 between 7:40 am and 11:40 am. Officers located the point of entry which was a second floor window. The suspect cut the screen giving him access to the house through the window. Once the window was open the suspect entered the house and stole two long guns and a bag. A resident in the area did observe an aqua colored vehicle driven by a white male earlier in the morning. According to the resident the driver left the area when he realized he was being watched. Residents are reminded to keep all windows and doors locked and to immediately report any suspicious activity.

Attempted Home Invasion: #2010-5877

On June 13, 2010 at approximately 4:50 am officers were dispatched to 1150 Paddock Place for a report of a home invasion in progress. The resident advised that she believed an ex-boyfriend was attempting to get into her residence through a rear window. The suspect had fled the scene while officers were responding.
