Home Invasion: #2010-7353

On July 21, 2010 at approximately 6:30 am. Officers were dispatched to the 2800 block of Green Valley Drive for a reported home invasion that occurred earlier in the night. The victim reported that an unknown suspect crawled through a garage window allowing them to access the house through the garage door. Once inside the suspect stole a wallet from the kitchen counter and left through a back door.

The victim noticed the garage window was open when they returned home but did not realize someone had broken into their house until the morning when the wallet was discovered stolen.
