WEEKLY FIRE REPORT

Total Calls for Service year to date: 1, 400

On July 17th 2011, fire fighters responded to a possible structure fire in the 1200 block of Heatherwood Lane. Fire crews arrived to find heavy smoke in the building. The cause was a kitchen fire that was then extinguished by the fire fighters.

On July 20th 2011, fire fighters responded to assist the Saline Fire Department on a house fire. Fire fighters helped with extinguishment, overhaul and investigation. One Saline fire fighter was seriously injured when he was electrocuted and was transported to the hospital via ambulance. Because of the extreme temperatures, five other fire departments were called in to assist.

On July 22nd 2011 fire fighters responded to a possible structure in the 5000 block of Data Court. Fire fighters arrived to find smoke in the building and began to investigate. The building had been evacuated prior to our arrival. The cause of the fire was a burned out motor in the server room.
