WEEKLY FIRE REPORT

Total Calls for Service year to date: 1, 472

On July 27^{th,} 2011, fire fighters responded to a reported structure with a person trapped in the 4500 Block of Swiss Stone Lane. Fire fighters arrived to find heavy smoke coming from a two story apartment building. There were two people trapped above the fire on second floor balconies but were rescued in time by fire fighters. Fire fighters then initiated an interior attack to extinguish the fire. The resident of the apartment of origin had suffered small burns and smoke inhalation and was transported to the hospital by ambulance. We were assisted by fire fighters from Ypsilanti and Ypsilanti Township.

Significant Criminal Events:

July 31, 2011, Incident # 11-7756, Breaking and Entering 5700 Block of Hines Drive: Over the past month there have been several incidents of breaking and entering to construction sites and businesses within Washtenaw County. Taken from these sites were miscellaneous tools and wiring. Collaborative efforts from local law enforcement agencies, including Eastern Michigan University D.P.S., the University of Michigan D.P.S. and the Pittsfield Township D.P.S., led to the successful apprehension of two suspects. The two suspects had just committed a breaking and entering at a business under construction in Pittsfield Township. The suspect vehicle was spotted and a traffic stop was initiated and the suspects were taken into police custody. Both suspects are residents of Ypsilanti Township, ages 33 and 48. One suspect was lodged at the Washtenaw County Jail and the second subject was transported to St. Joseph Hospital.
