### Weekly Public Safety Activity Summary August 2-8<sup>th</sup>, 2010

#### COMMUNITY EVENTS/INFORMATION

Oak Valley Drive resurfacing September 7<sup>th</sup>- October 29<sup>th</sup> provided there are no unforeseen delays: Residents and businesses located on Oak Valley Drive will be impacted by the road resurfacing project that will include 1.8 miles of new asphalt from Water St. to Scio Church Rd, ADA sidewalk ramps, adjust and repair of drainage structures and curbs, including gutter replacement, pedestrian refuge island to access Target strip mall property, additional sidewalks, pavement markings, and a new traffic control light at Waters St. and Oak Valley Drive.

Although local traffic will be allowed to travel on Oak Valley Drive during construction, there will be at least a five-day period in mid-October (18<sup>th</sup>-22<sup>nd</sup>) when the road will be completely closed to traffic for the surrounding neighborhoods and businesses. Residents in the area will be asked to use Water St. to enter and exit the subdivisions.

Carrying a Concealed Weapon, Possession with Intent to Deliver: #2010-7969

On August 6, 2010 at approximately 10:35 pm, an officer affected a traffic stop on a 2002 Lincoln Town Car. After making contact with the driver the officer was able to smell the odor of burnt marijuana coming from inside of the vehicle. The officer asked the driver if there was any marijuana in the vehicle and the driver produced a small amount and then attempted to dispose of it. The driver was asked to exit the vehicle and was then taken into custody. While the officer was searching the vehicle a loaded 45 caliber handgun was located in the glove box. Additionally, the officer located more marijuana that was packaged for delivery along with a police style radio. The driver was lodged at the Washtenaw County Jail and subsequently charged with carrying a concealed weapon. Charges for the suspected marijuana are pending lab results from the Michigan State Police.
