Type of Incident: Domestic Violence

On August 4th 2013 at 6:56 pm, Pittsfield Township Police responded to the 4900 block of Lone Oak Court for a domestic assault that occurred between acquaintances. One person was taken into custody.

Type of Incident: Felonious Assault

Information: On August 4th 2013 at 11:51pm, Pittsfield Police responded to the 4500 block of Washtenaw Avenue for a report of a 41 year old Ann Arbor Township resident who walked to the Washtenaw County Sheriff's Department parking lot after suffering a single stab wound to the chest. The subject indicated he had been involved in an altercation at a nearby residence. Officers were dispatched to a residence in the Arbor Meadows mobile home park for a report of another subject, a 25 year old male resident of Ypsilanti Township suffering from a stab wound to the arm. After determining the incidents were related, officers continued their investigation. It was determined both subjects had an altercation and each suffered a single stab wound as a result. Both subjects were transported to a local hospital with non-life threatening injuries. Officers are still investigating the incident attempting to determine if any other subjects were involved. No arrests have been made at this time.
