Breaking & Entering: # 2010-10273

On October 5, 2010 at approximately 8:45 pm, an officer was dispatched to the 4000 block of Chester Drive for a report of a home invasion. The officer made contact with the resident who advised that while she was gone earlier in the day an unknown suspect entered her apartment and stole two laptops. A subject was observed leaving the apartment carrying a bag while the resident was gone. The subject was described as a white male, 6'-0" tall, thin build with short blond hair. Breaking & Entering: # 2010-10429

On October 9, 2010 at approximately 10:11 pm, officers were in the parking lot of Meijer's in the 3100 block of Ann Arbor Saline Road assisting on a medical. An employee approached one of the officers and advised that loss prevention was attempting to stop a subject and needed their assistance. At that time the officer made the location of loss prevention in the parking lot, following a subject who attempted to steal \$381.00

worth of merchandise and was refusing to stop. The officer was briefed by loss prevention on what occurred at which time she ordered the subject to stop. The subject ran across the parking lot crossing Ann Arbor Saline Road and into another parking lot. The officer continued chasing the subject and located him hiding against a tree. The subject was again given commands to get onto the ground and when he began to flee the officer attempted to tase the subject. The officer located the subject lying in weeds. The subject continued to resist arrest and the officer was able to take the subject into custody. The subject was arrested and lodged at the Washtenaw County Jail pending authorization of charges. On October 10, 2010 the subject was charged with one count of Assaulting/Resisting/Obstructing a Police Officer and one count of Retail Fraud 1st degree. The subject is a 46 year old Ann Arbor resident.
