#### WEEKLY FIRE REPORT

October 29, 2010, apartment fire 3100 Block of Woodland Hills Dr.:

The Pittsfield Township Fire Department was dispatched to the report of an apartment fire. Firefighters arrived on-scene and found a fire in the bedroom of a third floor apartment. A line was stretched and the fire extinguished. There were no civilians or firefighters injured and two cats were rescued from the fire apartment. Investigation is ongoing and cause of the fire is yet to be determined.

#### Significant Criminal Events:

Armed Robbery: #10-11170

On October 29, 2010, Officers responded to the 4000 Block of Stone School Road on a report of an armed robbery where two suspects entered the establishment and ordered two employees to the ground at gunpoint, demanding cash from the register. The two suspects then fled on foot from the scene. An Ann Arbor K-9 unit responded to the scene to assist officers in the search for the suspects. Officers were unable to locate the suspects. Both suspects were black males, one early to mid 20's, 5'6-5'7, in height, thin build, the second was in his early to mid 20's 6'0, thin build. Both had scarfs over their faces and wearing black hooded sweatshirts. Anyone who may have witnessed the incident is asked to contact the Pittsfield Department of Public Safety.

**Home Invasion: # 2010-11196**

On October 30, 2010 at approximately 3:13 pm, officers were dispatched to the 5200 block of Buckley Drive for a reported home invasion in progress. Witnesses saw two suspects at the front door of a residence and then watched as the suspects walked around to the rear of the house. A witness then observed one of the suspects return to the front of the house, pick up a large rock and return to the rear of the house. The witness was concerned that the suspects may have been breaking into the house and with the assistance of another subject approached the house and rang the doorbell. The suspects were then observed running from the house through the backyard carrying two bags. The witnesses followed the suspects through the yard and observed the suspects get into a dark blue or black older style Ford vehicle. The witnesses then contacted the police to report the incident. The vehicle was last seen traveling westbound on Textile Road. The homeowner was contacted and returned home. The suspects stole a laptop, gaming station and prescription medication.

The first suspect was described as a black male, light skin complexion, approximately 16 years old, 5'-8" tall, thin build, last seen wearing dark baggy jeans, a blue or black jacket with a red baseball hat. The second suspect was described as a black male, dark complexion, 18 years old, 5'-5" tall, thin build, last seen wearing blue jeans, light blue jacket with a gray baseball hat. Anyone who may have witnessed the incident is asked to contact the Pittsfield Department of Public Safety.

**Home Invasion / Assault with Intent to Commit Murder: 2010-11203**

On October 30, 2010 4:45 pm, officers were dispatched to the 4000 block of Green Meadows Blvd. for a report of a person who had unlawfully entered an apartment and was choking the resident. Upon officers arrival the suspect was stopped and detained as he was climbing off of the balcony. The victim reported that the suspect showed up at the apartment and was demanding to be let in. After not being allowed in the suspect climbed up onto the balcony and walked in to the apartment after another subject opened the door to tell him to leave. The victim stated that once the suspect was in the apartment he was pushed to the ground by the suspect and the suspect then wrapped his arm around him and began choking him. The victim indicated that he was able to throw his phone to the other subject in the apartment to call the police before he lost consciousness. The suspect reportedly let go of the victim after he had passed out and began apologizing for his actions. The victim stated that when he awoke he vomited and that the police arrived shortly after. The suspect was arrested and lodged at the Washtenaw County Jail pending review of the case by the prosecutor's office. On October 31, 2010 the suspect, Gregory Jones of Ypsilanti was charged with Assault with intent to commit murder, Assault involving great bodily harm and Home invasion 1<sup>st</sup> degree.
