On November 4, 2010 at approximately 4:10 pm, an officer was dispatched to the Target store on Carpenter Rd. for a report of a retail fraud in which a person was in custody for four separate incidents. Loss prevention advised the officer that the person in custody had entered the store on three previous dates and selected CD's. The suspect then concealed them in a backpack and proceeded out the doors without making any attempt to pay for the items. The suspect returned again on November 4, 2010 attempting to commit the same crime when loss prevention was able to stop and detain him. The suspect admitted to the crimes and property that had been previously stolen was recovered from his backpack. The suspect was identified as a

28 year old male from Ypsilanti, Michigan. The cases have been submitted to the Washtenaw County Prosecutor's Office for review.
