#### **FTC: [Annualcreditreport.com](http://Annualcreditreport.com) - Don't be fooled by Imposter Websites**

Only **one** website is authorized to fill orders for the free annual credit report you are entitled to under law, [annualcreditreport.com](http://annualcreditreport.com). Other websites that claim to offer “*free credit reports*,” “*free credit scores*” or “*free credit monitoring*” are not part of the legally mandated free annual credit report program. In some cases, the “free” product comes with strings attached. For example, some sites sign you up for a supposedly “free” service that converts to one you have to pay for after a trial period. If you don't cancel during the trial period, you may be unwittingly agreeing to let the company start charging fees to your credit card.

Some “*imposter*” sites use terms like “*free report*” in their names; others have URLs that **purposely misspell [annualcreditreport.com](http://annualcreditreport.com)** in the hope that you will mistype the name of the official site. Some of these “imposter” sites direct you to other sites that try to sell you something or collect your personal information.

**[Annualcreditreport.com](http://Annualcreditreport.com)** and the nationwide credit reporting companies will not send you an email asking for your personal information. If you get an email, see a pop-up ad, or get a phone call from someone claiming to be from [annualcreditreport.com](http://annualcreditreport.com) or any of the three nationwide credit reporting companies, do not reply or click on any link in the message. It's probably a scam. Forward any such email to the FTC at [spam@uce.gov](mailto:spam@uce.gov). Click on the link to access the site.

### **Police Incident: Fatal Traffic Crash**

Complaint # 15-622

**Information:** On January 16, 2015, at 6:36 a.m., Pittsfield Police and Fire were dispatched to the corner of State Rd. and Lavender Ln. for a car vs. bicyclist traffic crash. Upon arrival it was determined that a vehicle traveling northbound on State Rd. struck an unidentified male subject who was either walking with or riding his bicycle on northbound State Rd. Huron Valley Ambulance transported the male subject to a local hospital where he was pronounced dead. The driver of the vehicle was transported to a local hospital for minor injuries and released shortly thereafter. There is an active crash investigation being conducted by the Pittsfield Twp. Accident Investigation Unit.

**Injuries:** Fatal injuries sustained by an adult male from Defiance Ohio.

**Police Incident: Street Robbery- Armed**

Complaint # 15-566

**Information:** On January 14, 2015, at 8:10 p.m. Pittsfield Township Police Officers were dispatched to a business in the 4900 block of Washtenaw Ave. for an armed robbery that had occurred. The victim reported that he was sitting in his vehicle at the location when a black male, 20-30 years old, 5'7" to 5'9", average build asked for a cigarette. The suspect produced a knife and demanded money from the victim.

The victim turned over his money and fled the area in his vehicle. The suspect was last seen wearing a black leather coat with multiple dollar signs of different colors. The suspect was also described as having a "busted" or injured upper lip on the right side of his face. The suspect fled in an unknown direction. There were no injuries.
