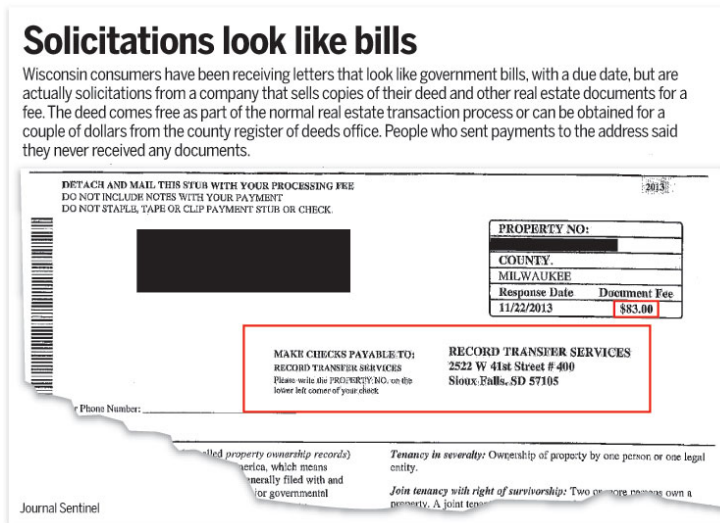
Crime Map for the Week April 19th- 25th, 2015

Several commercial services offer property owners certified copies of their deeds via mail for as much as \$83.00 per deed. The same document is available to property owners for as little as \$2.00 from the Washtenaw County Register of Deeds Office.
