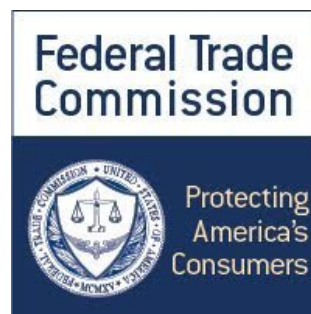
Federal Trade Commission: Spread the word about government imposters

We're hearing from our colleagues that those pesky government imposters are at it again, using the FTC's name to try to con people into paying them for something. Whether it's to clean up your credit report, give you a prize, resolve a complaint against you, or pay off a debt you owe, they're all lies. The message may be a call or an email, but it isn't from the Federal Trade Commission, or any other federal agency. Here's the bottom line: if someone claiming to be a government employee asks you to send money to collect a prize or remove negative information from your credit report, don't do it. And don't give them your personal or financial information, either.

As long as the scammers keep posing as government officials, we'll keep putting out [warnings](#) like this one. But we need your help to spread the word. Talk to your friends. Tweet it. Post to your social networks. Blog about it. You just might help someone you care about avoid falling for a scam.
