Dear Ms. Grewal:

I am writing to update you on the status of the Line 6B Pipeline Replacement Project.

On October 1, 2014, the new pipeline was placed into service, marking more than two years of pipeline construction and \$2.6 billion in capital investments to replace and expand 285 miles of Enbridge's pipeline system in Michigan and Indiana. While the new pipeline may be in service, we recognize that our work on the right-of-way is not yet complete. We are still in the process of deactivating the original Line 6B pipeline. We are also restoring properties affected by construction. The restoration work will continue as long as weather permits and will resume in the spring when Enbridge crews return to reseed, plant trees, and perform other necessary tasks on properties that have not already been restored.

Because this work is ongoing, Enbridge crews will continue to be present in some communities, so the potential for issues and concerns to be raised by landowners and the public still exists. Therefore, Enbridge is maintaining its restoration offices in Valparaiso, Indiana and Shelby Township, Michigan, and the project toll-free number (1-866-410-4356) will remain active as long as is necessary. Should you be contacted by your constituents, we encourage you to direct them to one of these resources.

Line 6B is an integral part of the region's critical energy infrastructure, providing a safe and efficient crude oil transportation system for reliable delivery of North American crude oil to numerous refineries in both the U.S. and Canada. As a result of the Line 6B Pipeline Replacement Project, the capacity of the system has been restored and there should be fewer maintenance activities in the future.

On behalf of Enbridge, I want to thank you for your patience, cooperation and understanding during the construction process. ## Replacement pipeline is operating and right-of-way is being restored



The Line 6B replacement pipeline is operating and delivering secure supplies of North American crude oil. Restoration activities such as grading, seeding and mulching of the right-of-way are substantially complete but challenging areas are still being addressed. While there is landscaping work to complete in some residential areas, most of the dirt work requiring heavy equipment is finished. Project restoration crews are becoming smaller and in many cases have completed their work. Crews will continue working on the right-of-way this fall as long as weather permits. Restoration crews will be back in the spring as soon as possible to make sure properties are returned to their pre-construction condition.

### Dear Landowners and Public Officials:

Enbridge is now operating the entire 285 miles of the replaced Line 6B pipeline system. This means Enbridge can continue meeting the petroleum needs of refiners and consumers in Michigan, Indiana, and neighboring communities with North American produced crude oil.

The Line 6B system has been improved through the use of heavier wall pipe, new coating, additional remote operated valves and a new cathodic protection system.

Enbridge's total capital investment has been approximately \$2.6 billion, which includes the replacement pipe, pump stations, and associated station and terminal facilities. The work involved nearly 8 million hours of labor. Enbridge property taxes associated with the replacement pipeline have increased and will continue to benefit the communities where Enbridge operates.

The remaining work includes deactivating the original Line 6B and completing restoration efforts. Property restoration work will continue until winter weather forces a suspension of restoration efforts. Enbridge's goal is to provide a high-quality restoration job that meets the expectations of landowners, as well as regulators, public officials and the communities in which Enbridge operates.

The restoration crews will return in the spring of 2015 to reseed areas that did not germinate and continue restoration efforts on all properties that have not been returned to as close to pre-construction condition as possible.

Enbridge strives to uphold the commitments it made relative to the replacement of the pipeline across your property. If you have any issues or concerns related to restoration, please contact your land agent. As the priority is now focused on restoration activities, it is possible that you may be working with a different agent.
