WEEKLY FIRE REPORT

Total Calls for Service year to date: 2,529

On 12-29, fire fighters responded to a reported structure fire in the 2000 block of Glencoe Hills Drive. Fire fighters arrived to find heavy smoke and flames coming from the three story apartment building. Fire fighters started an aggressive interior attack but the fire spread into the attic. As more crews arrived on the scene the fire was brought under control in about an hour. No injuries were reported and the cause of the fire appeared to have been from maintenance crews working earlier in the day. Ypsilanti Township and Ypsilanti City fire departments assisted at the scene.

On 12-29, Pittsfield Township Fire Department and members of the Washtenaw County Technical Rescue Team responded to the City of Wayne to assist in the search and recovery effort of the furniture store explosion. Our crews were able to find and remove the final victim.

On 12-30, Pittsfield Township Fire Department was called to assist the Milan Area Fire Department on a fully involved house fire in the 1000 block of Judd Road. Fire crews assisted in the extinguishment and overhaul of the fire.

On 12-31, Pittsfield Township Fire Department was called to assist the Ann Arbor Fire Department on a structure fire on Blaney Drive in the Southwest portion of the city. Pittsfield fire fighters provided a Rapid Intervention Team for the duration of the incident.

Felonious Assault: 2010-13402

On December 31, 2010 at approximately 6:37 pm officers were dispatched to the 4500 block of Washtenaw Ave. for a report of a subject swing an object at passing vehicles. Officers located the subject standing outside of an Ann Arbor Transit Authority bus yelling for the bus driver to open the door. The subject was holding a silver object in his right hand and a mailbox in his left hand. The officer ordered the subject to drop the weapons at which time the subject began walking towards the officer. The officer was able to identify the object as a tire iron and was about to Taser the subject when the subject turned around and returned to his vehicle which he had left on Washtenaw Ave. The subject then began driving away while another officer was behind him attempting to get him to pull over and stop.

The subject pulled in behind a business and the officers were able to block the subject from leaving. After being ordered to drop the tire iron and to turn the vehicle off the subject backed his vehicle into one of the police cars. At that time the officers were able to open the subject's door and Taser him. An officer reached in and removed the tire iron from the subject and then the subject was removed from the vehicle and taken into custody. Due to the subjects actions he was transported to a local hospital to be psychologically evaluated. The case will be forwarded to the Washtenaw County Prosecutor's Office for review
