Michigan’s “Internet Privacy Act” House Bill - #5523:

Michigan House Bill #5523: “An act to prohibit employers and educational institutions from requiring certain individuals to grant access to, allow observation of, or disclose information that allows access to or observation of personal internet accounts; to prohibit employers and educational institutions from taking certain actions for failure to allow access to, observation of, or disclosure of information that allows access to personal internet accounts; and to provide sanctions and remedies”. False Alarm Ordinance – Article III - #233: Pittsfield Township’s False Alarm ordinance is based on a yearly calendar cycle (January – December). The new cycle started January 1, 2013. A false alarm charge will not be assessed for the first two (2) false alarm responses. Third and subsequent false alarm responses will result in a charge of 100.00 per incident/response. **NOTE:** Regardless of the number of false alarm responses, only one false alarm response will be charged during any 24-hour period (12:00 a.m. to the following 11:59 p.m.) per location/address.
