Federal Trade Commission alert-Data Privacy: February 3, 2011, "Credit Report Resellers Settle FTC Charges; Security Failures Allowed Hackers to Access Consumers' Personal Information". The FTC has reported security breaches by hackers into the three companies' networks that purchase consumer information from the credit bureaus Equifax, Experian and TransUnion. As a result, hackers accessed more than 1,800 credit reports without authorization via the client's computer networks. FTC; "In addition, even after becoming aware of the data breaches, the companies didn't make reasonable efforts to protect against future breaches". WEEKLY FIRE REPORT

Total Calls for Service year to date: 279

On January 31st, 2011, fire fighters responded on a mutual aid request for Ypsilanti Township Fire Department in the 1200 block of Concord Street. Fire crews helped extinguish a fire in an apartment complex. One Pittsfield Township fire fighter was treated at the hospital for a minor facial injury.

On February 3rd, 2011, fire fighters responded on a mutual aid request for Ypsilanti Township Fire Department in the 5000 block of Stoney Creek Road. Fire fighters assisted in search and rescue operations and extinguishment of the fire. One civilian was killed and another was seriously injured in the fire.

On February 3rd, 2011, fire fighters responded to the 2500 block of Morgan Road for a possible structure fire. Fire crews arrived to find smoke coming from the porch area where a propane heater had caused a fire. The fire was extinguished and fire fighters performed overhaul operations.

On February 4, 2011 at approximately 6:45 am, the Pittsfield Township Police responded to the Saint Joseph Hospital for a report of a person reporting to have been kidnapped. Upon the officers arrival he made contact with a 28 year old Scio Twp resident. The victim stated that she had a verbal argument with her boyfriend and agreed to drive him to a friend's apartment located on Chester Drive in Pittsfield Township. The victim advised that once they arrived at the apartment the suspect refused to exit the vehicle and produced a knife, threatening the victim and making her drive him to Detroit. While en-route to Detroit the suspect damaged the dashboard of the vehicle as well as caused minor injuries to the victim's leg with the knife. Once in Detroit the victim stated she was able to exit the vehicle at a gas station and stay behind the counter with the clerk until the Detroit Police arrived. The suspect had fled the scene with the vehicle which was later recovered. After speaking to the Detroit Police and retrieving her vehicle the victim drove to Saint Joseph Hospital for medical treatment.

The suspect returned to the victim's residence in Scio Township on February 5, 2011 and was taken into custody without incident. The suspect, a 32 year old Scio Township resident remains in custody pending review of the case by the Washtenaw County Prosecutor's Office.
