On February 12, 2011, officers were dispatched to the area of Washtenaw Ave. and Golfside Rd. for a report of a retail fraud in which a suspect had just stolen two boxes of Snickers along with approximately twenty-five knit hats. Upon arrival the officer's received a call from the adjacent gas station advising that a suspect matching the first incident had just pulled a knife and stole approximately two dozen magazines. Officers were able to track the suspect through the fresh snow to an apartment complex north of the location. The officers received consent from the homeowner to enter the apartment and took the suspect into custody with assistance from the Washtenaw County Sheriff's Department.

The suspect, Shawn Evans of Ypsilanti Township has been charged with armed robbery, unarmed robbery, resisting and obstructing, and larceny in a building. Bond was set at \$15,000.
