FTC Warns Marketers That Mobile Apps May Violate Fair Credit Reporting Act

On February 27th, 2012, The Federal Trade Commission warned marketers of six mobile applications that provide background screening apps that they may be violating the Fair Credit Reporting Act. The FTC warned the app marketers, if they have reason to believe the background reports they provide are being used for employment screening, housing, credit, or other similar purposes, they must comply with the Fair Credit Reporting Act. Information: Pittsfield Police responded to the report of a home invasion that occurred in The Pines of Lake Forest. The victim, a 19-year-old male, reported being confronted by four unknown subjects that had forced entry into his residence through a rear glass door. One subject displayed a knife and the victim was tied up while the suspects removed undisclosed property from the home. An Ypsilanti Police K-9 assisted with a track, but officers were unsuccessful in locating the suspects. The incident remains under investigation.

There were no injuries or arrests.

Suspect(s): four (4) unknown black males, in their 30's, three (3) wearing black jackets and one wearing a navy jacket. All were said to have been wearing University of Michigan hats.

UPDATE 2/28/12

Further investigation revealed that the youngest of the four subjects ranged in age from thirty to thirty-five. The other three subjects were older, ranging in age from late forties to early fifties. All of the subjects averaged approximately 6 feet tall with medium builds.

A white Dodge Charger with the word Charger on the windshield was seen in the area prior to the incident. Another vehicle that may be related to this incident is a blue SUV. The investigation continues and the detective bureau is following up on leads they have received regarding this incident.

This is an active ongoing investigation.
