On May 5, 2011 the Pittsfield Township Police Department was advised of a criminal sexual conduct incident that occurred in the township on May 3, 2011. The detective bureau began an investigation resulting in the

arrest of two township residents. The victim, a 20 year old Dexter Township resident, reported that she was held against her will and sexually assaulted.

Both suspects have been charged with one count of kidnapping and two counts of criminal sexual conduct 1st degree. Arrested were Kyle Seyfried and Donna Jones.

The case remains under investigation by the detective bureau.
