Breaking and Entering: # 2011-5157

On May 26, 2011 at approximately 4:25 am, the Pittsfield Township Police Department received a call from the cleaning crew at the Rave Cinemas located at 4100 Carpenter Rd. The staff was reporting that a vehicle had just backed through a window and a suspect was attempting to steal a coin machine near the video games. Officers were dispatched and as Officer DeLaPena pulled into the lot he observed a vehicle attempting to flee. The vehicle was observed driving without its headlights on as it drove over the grass and a curb attempting to get onto Carpenter Rd.

Officer DeLaPena attempted to stop the vehicle as it entered onto Carpenter Rd. The vehicle, a late 1990's or early 2000's, red Chevy Camaro or Chrysler Sebring had an object covering the license plate. The vehicle traveled south on Carpenter Rd. turning onto Morgan Rd., then onto Michigan Ave. Officer DeLaPena was attempting to read the license plate as the vehicle fled since the object continued to move up and down as the vehicle traveled. The vehicle was last observed getting onto Eastbound I-94.

The driver was described as a white male, 6'-0", between 250-280 lbs, last seen wearing a mask, gloves and work coveralls.

Damage to the building was a broken window. At the time of the report a cost for the damage was not available.
