Felonious Assault / Malicious Destruction of Property: # 2011-5709

On June 9, 2011 at approximately 2:52 am, the Pittsfield Township Police Department received a 911 call from a person reporting a subject being threatened and property being damaged in the 4000 block of Green Meadows Blvd. Upon the officers arrival they made contact with the victim who advised he had been threatened with a gun and the suspects broke out the windows to his vehicle.

The victim stated that he is in a relationship with a female and an ex-boyfriend of the female was waiting for him when he returned home. The victim then stated that the ex-boyfriend and another male got out of a vehicle and approached him at his vehicle. Both suspects were holding flashlights and broke the victim's rear window of the vehicle as they approached.

The victim indicated that he then began fighting with one of the suspects when the other retrieved a gun from the vehicle. The victim stated that he then produced a gun and then fled the immediate area. The victim advised that as he ran he saw the suspects then break his windshield and leave in their vehicle.

One of the two suspects has been identified and the case remains under investigation.
