On July 13, 2010, at approximately 1:03 pm. an Officer was dispatched to the 4100 block of Ridgewood Drive for a reported criminal sexual conduct case involving a 15 year old female victim and a 27 year old male suspect. Upon the Officers arrival it was discovered that the suspect may have been having a sexual relationship with the victim for more than a year. Additionally, family of the victim discovered electronic evidence of the relationship. The suspect was arrested a short time later and a search warrant was conducted on the suspect's residence. The case was presented to the Washtenaw County Prosecutor's Office and charges were authorized against the suspect. The suspect has been charged with three counts of criminal sexual conduct 1st degree, one count of child sexually abusive activity along with one count of child sexually abusive material, possession.

Home Invasion: #2010-7222

On July 18, 2010, at approximately 2:25 am. Officers were dispatched to the 2000 block of Arbor Circle West for a reported home invasion. The victim returned home after being out for a few hours and discovered that her front door had been kicked in. The victim further reported that the suspect had gone through dresser drawers and emptied a jewelry box. The victim also stated that the suspect took a flat screen television, a laptop, camera, along with jewelry. Officers were also advised by the victim that she observed the same damage to a neighbor's apartment but after further investigation it does not appear as though anything had been stolen.
