Breaking and Entering: # 2011-8033

On Monday, August 8, 2011 at 9:15 am, the Pittsfield Township Police Department received a 911 call from an employee of a Rock Construction Company reporting that someone was currently stealing from a construction trailer. The caller was able to give a description of the suspects as well as the vehicle they were in. As officers were responding they located a vehicle matching the description in the area of Platt Rd. and Michigan Ave. The officers stopped the vehicle and immediately observed tools in the vehicle.

The employee was called to the scene and later identified the property in the vehicle as belonging to the construction company. The suspects were arrested and lodged at the Washtenaw County Jail.

The case was submitted to the Washtenaw County Prosecutors Office and charges were authorized against the driver of the vehicle. The driver, John Brunk of Lansing Michigan was charged with one count of Breaking and Entering as well as one count of Larceny.
