#### COMMUNITY EVENTS/INFORMATION

**Community Alert:** On August 20<sup>th</sup>, Pittsfield Township Police issued an alert addressing the increase in the theft of catalytic converters and valuables left in vehicles. The alert has been posted on the townships website.

**West Nile Virus:** On August 20<sup>th</sup>, Pittsfield Township issued an alert that the West Nile Virus had been identified in the Township. It was confirmed that it was a human case reported to the Washtenaw County Public Health Department. Residents are encouraged to eliminate standing water on their property, which is a breeding ground for mosquitoes, and report dead birds to the county's West Nile hotline at 734 544-6750.
