Assault & Battery: # 2010-10087

On October 1, 2010 at approximately 2:00 am, officers were in the parking lot of the 4700 block of Washtenaw Ave. due to a large crowd of people leaving an establishment. Officers were advised of an assault that was taking place between several subjects at which time they were able to locate two victims. The victims stated that they were attempting to leave the establishment when they were confronted by three females who began assaulting them. The victims indicated that they did not know the suspects or why they began assaulting them. The victims advised that the suspects left as the officers were approaching. Due to the large crowd the officers were not able to identify the suspects. The victims were treated for minor injuries at a local hospital.

**Breaking & Entering: # 2010-10130**

On October 2, 2010 at approximately 8:20 am, an officer was dispatched to the 7000 block of Munger Road for a reported breaking and entering of a detached garage. The officer was advised by the homeowner that he last observed the garage secured the night before and that sometime during the night an unknown suspect forced open a side garage door. The homeowner stated that the suspect stole tools, car parts, and yard equipment. The value of the stolen items is estimated to be over \$10,000. Anyone who may have witnessed any suspicious vehicles in the area during the night is requested to call the department.
