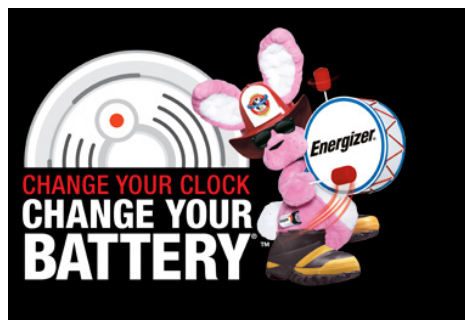

### **Significant Criminal Events:**

Report # 11-11310

On October 27<sup>th</sup>, 2011 at 7:54am, Officers responded to the above location on a report of a breaking and entering in progress. Officers located and detained two male subjects (one adult and one juvenile) along with one adult female subject. Investigation revealed that the two male subjects attempted to enter an occupied dwelling by forcing open the front door, while the female waited inside vehicle. The adult male subject was lodged at the Washtenaw County Jail pending charges of Attempted Home Invasion. The juvenile and adult female subjects were both released and charges are being submitted for review by the Washtenaw County Prosecutor's Office for Attempted Home Invasion. Regional Hunter of Inkster Michigan was charged with one count of Home Invasion 1<sup>st</sup>, bond of \$10000 – 10%.
