WEEKLY FIRE REPORT

On Tuesday, November 30th fire personnel were dispatched to a multiple vehicle accident in the area of Michigan Ave. and Munger Rd. Fire crews arrived to find one person stuck in a vehicle and four other injuries in other vehicles. Fire fighters used the "Jaws of Life" to extricate the trapped person and attended to the injuries of the other people involved. Five people were transported to area hospitals.

Armed Robbery: 2010-12382

On 12-04-2010, at approximately 1028 am, officers from the Pittsfield Township Department of Public Safety were dispatched to the 3200 Block of Carpenter Rd. for an armed robbery that just occurred. The victim is a 24 year old Pittsfield resident who was walking on Carpenter Rd near Green Meadows Blvd. when he was approached by two black males. One of the two suspects implied he had a gun and would shot the victim if he did not turn over his money. An officer was able to locate the suspects in the 3000 block of Woodland Hills Dr. The officer was able to take one of the suspects into custody after a foot pursuit. The suspect is a 26 year old Ypsilanti resident. He was lodged at the Washtenaw County Jail pending review of the case by

the Washtenaw County Prosecutor's Office. The second suspect has been identified and the investigation continues.
