Community Table Guidelines & Application

The mission of the Pittsfield Township Farmers Market is to strengthen and support local and regional food and agricultural businesses, increase healthy and wholesome food access, and promote community interaction. Keeping in line with our mission, the Community Table provides a platform for local non-profit organizations to share their stories, and educate the public on services offered in our community that relate to the mission of the Pittsfield Township Farmers Market.

Community Table Guidelines (add from vendor guidelines)

1. Participation is limited to one time a year, when space is available.
2. Sales or distribution of any goods shall not compete with any established Farmers Market vendor.
3. Donations may be accepted.
4. All Community Table activities must be conducted at the Community Table space. Staffers may not move around the Market to sell their message in any way that would disturb market-goers or vendors.
5. All signage must be within Market Vendor Guidelines, and be family friendly.
6. Set-up and take down is the responsibility of the vendor.
7. Farmers Market Vendor Rules apply (a copy is provided on our web page).
