Pittsfield Charter Township Department of Building Services COVID-19 Operation Plan

In response to Executive Order 2020-70 enacted by Governor Whitmer on May 1st, 2020, the Department of Building Services has resumed Building, Electrical, Mechanical, and Plumbing inspections. Property maintenance inspections for rental properties remain suspended until further notice. Building and Trade inspections will be limited to inspections required to move construction forward and inspections where a wide and clear path can be provided to maintain safe distancing. All job sites are required to adhere to all provisions of Executive Order 2020-70.

The Administrative Office remains closed to the public. We are accepting permit applications via mail, email, or drop box located at the Administrative Office.

Building Department voicemails and emails will continue to be monitored remotely to the maximum extent possible.
