## Review of Notable Crime Activities April 1, 2020 - April 30, 2020

- ➤ Zero Homicides occurred this April, as well as last April. YTD, homicides have remained the same. (0 this year compared to 0 last year).
- ➤ One (1) Criminal Sexual Conduct (CSC) offense occurred this April compared two (2) to last April showing a decrease of 50%. YTD, CSC offenses have increased 50% (6 this year compared to 4 last year).
- > Zero (0) Robberies occurred this April, as well as last April. YTD, robberies have increased 66.67% this year compared to the same time last year (5 this year compared to 3 last year).
- ➤ One (1) Aggravated Assault occurred this April compared to four (4) last April showing a decrease of 75%. YTD, aggravated assaults have decreased 37.5% this year compared to the same time last year (10 this year compared to 16 last year).

- > Two (2) Burglaries Residential occurred this April compared to five (5) last April showing a decrease of 60%. YTD, residential burglaries have decreased 42.86% this year from the same time last year (8 this year compared to 14 last year).
- ➤ One (1) Burglary All Other occurred this April, as well as last April. YTD, Burglaries All Other have increased 25% this year from the same time last year (5 this year compared to 4 last year).
- ➤ Seven (7) Larcenies occurred this April compared to fifteen (15) last April showing a decrease of 53.33%. YTD, larcenies have decreased 25.53% this year compared to the same time last year (35 this year compared to 47 last year).
- Larcenies from Vehicles decreased 51.17% this April (11) compared to last April (23). YTD, larcenies from vehicles decreased 43.18% this year from last year (25 this year compared to 44 last year).
- ➤ One (1) Motor Vehicle Theft (MVT) occurred this April compared to five (5) last April showing a decrease of 80%. YTD, MVT decreased 43.75% this year from last year (9 this year compared to 16 last year).
- Five (5) Malicious Damage of Property (MDOP) incidents occurred this April compared to three (3) last April showing an increase of 66.67%. YTD, MDOP offenses have increased 35% this year from last year (27 this year compared to 20 last year).
- ➤ Drug/Narcotic violations decreased 87.5% this April (3) compared to last April (24). YTD, drug/narcotic violations decreased 41.54% this year from last year (38 this year compared to 65 last year).
- Two (2) Operating under the Influence (OUI) arrests occurred this April compared to six (6) last April showing a decrease of 66.67%. YTD, OUI arrests have increased 22.73% this year from the same time last year (27 this year compared to 22 last year).
