Review of Notable Crime Activities July 1, 2020 – July 31, 2020

- Zero (0) Homicides occurred this July compared to one (1) last July showing a decrease of 100%. YTD, homicides have decreased by 100% this year compared to the same time last year. (0 this year compared to 1 last year).
- Three (3) Criminal Sexual Conduct (CSC) offense occurred this July compared to one (1) last July showing an increase of 200%. YTD, CSC offenses have increased 33.33% (12 this year compared to 9 last year).
- Zero (0) Robberies occurred this July compared to one (1) last July showing a decrease of 100%. YTD, robberies have increased 40% this year compared to the same time last year (7 this year compared to 5 last year).
- Two (2) Aggravated Assaults occurred this July compared to three (3) last July showing a decrease of 33.33%. YTD, aggravated assaults have decreased 18.52% this year compared to the same time last year (22 this year compared to 27 last year).

- Three (3) Burglaries – Residential occurred this July compared to one (1) last July showing an increase of 200%. YTD, residential burglaries have decreased 56% this year from the same time last year (11 this year compared to 25 last year).
- Three (3) Burglaries – All Other occurred this July, as well as last July. YTD, Burglaries – All Other have remained the same this year from the same time last year (10 this year compared to 10 last year).
- Ten (10) Larcenies occurred this July compared to fourteen (14) last July showing a decrease of 28.57%. YTD, larcenies have decreased 27.47% this year compared to the same time last year (66 this year compared to 91 last year).
- Larcenies from Vehicles decreased 57.69% this July (11) compared to last July (26). YTD, larcenies from vehicles decreased 56.76% this year from last year (48 this year compared to 111 last year).
- Four (4) Motor Vehicle Thefts (MVT) occurred this July compared to seven (7) last July showing a decrease of 42.86%. YTD, MVT decreased 45.16% this year from last year (17 this year compared to 31 last year).
- Twelve (12) Malicious Damage of Property (MDOP) incidents occurred this July compared to nine (9) last July showing an increase of 33.33%. YTD, MDOP offenses have increased 3.77% this year from last year (55 this year compared to 53 last year).
- Drug/Narcotic violations decreased 42.86 this July (8) compared to last July (14). YTD, drug/narcotic violations decreased 31.25% this year from last year (77 this year compared to 112 last year).
- Four (4) Operating under the Influence (OUI) arrests occurred this July compared to seven (7) last July showing a decrease of 42.86%. YTD, OUI arrests have decreased 9.1% this year from the same time last year (40 this year compared to 44 last year).
